Wear your coolest cowboy clothes and remember to hydrate. I believe Caprock is developing some stages that will speed things up so we can beat the heat.

We've been having informal conversations on how to develop a recruiting program to bring in new members, especially younger members. Here are some of the ideas I recall hearing over the last couple of months.

#### 1. Advertise:

- a. Set up an information table at the monthly gun show(s).
- b. Develop a video presentation showing a variety of age groups participating in matches.
  - i. Laptop presentation to be used at gun shows and other appropriate venues.
    - ii. Update our website with videos and photos'

- 2. Introduction to CAS:

- 3. Lower the cost of entry:
  - a. Work with gun stores to come up with a cost effective package for new members to get started.b. Put a classified section on our website so members can buy and sell

# NOTES FROM THE RANGE MASTER - DOWN RANGE!

Hope you enjoyed the "May the Fourth Be With You" themed match for May. Wish I had recorded the Yoda voices. Thanks to Newt Ritter for suggesting and assisting in the stage writing.

Speaking of the fourth, I mean force; believe Beauregard Beard was channeling it. Beau shot the match in 97.39 seconds; averaging 0.93 seconds a shot! ...and that includes a can tosser and the swinger! Then just to make it even better - he shot it CLEAN! (The force is strong in this one.) Picosa Kid was only 0.93 seconds behind him averaging 0.94 seconds a shot. Strip out bonuses and Beau shot a 102.39/0.98 and Picosa shot 113.3/1.08. The rest of us were waaaay back there. Nine shooters got the bonuses on Stage 1 (can tosser) and nine got at least one flag wiggle on Stage 4. Picosa and Latigo Lee were the only shooters to get all three bonuses (bonii?).

Reminder that for June's match you can shoot Josey Wales (JW) category, but it is not required. (If you don't know who Josey Wales is...google it...and watch the movie!) Bottom line - JW shooters shoot pistols in lieu of a rifle. These pistols will be shot at the rifle targets. Yes, I said "at" - for some of us it will be "in the general direction" of the rifle targets. Guess we will be using that thingy on the end of the barrel! Please let Long John Beard and Natalia Sue know you are shooting JW when you sign in. Yes, you can shoot .22LR for JW and yes, you can swap cylinders in pistols for JW just watch the 170 rule.

DO NOT wear all four pistols in holsters on your leather. Your JW pistols MUST be staged so bring a gun bag to carry your JW pistols to the loading table. A 'facilitator' will make sure your gun bag gets from the loading table to the unloading table. While moving with JW pistols, please keep the barrels pointed up to prevent sweeping others.

JW shooters may shoot their shotguns or can shoot a pistol in lieu of shotgun. The pistol must be loaded on the clock like you would a shotgun. "Stoking on the clock" is allowed so pistol may be loaded with up to five rounds! Like the shotgun, you shoot until you get a hit. Knockdowns do not have to go down. You may use a fifth pistol (staged empty and open if design allows)) or reload one of your other pistols. Which pistols (holstered or staged) that is reloaded will depend on where they are staged and fired and will be described in the stage instructions. Derringers and pocket pistols are allowed for shotgun substitution, but you must hit the target! Derringer shooters be careful not to sweep yourselves or others when loading.

I cannot be there for setup on Friday, 31 May so will need assistance in getting the stages set up.

'Nough said...if you have shot, swap out, brass is up, targets are up, shooter up!



#### The Fight at Espantosa Lake

By 1876, famed Ranger Captain Leander McNelly was in San Antonio, enduring the last stages of tuberculosis while in the care of Dr. Cupples. (If you ever wondered about how Cupples Road got its name...)

McNelly had a second-in-command in the form of Ranger Sergeant John Armstrong, who came to be known as "McNelly's Bulldog." King Fisher had long been a thorn in McNelly side. He had evaded several attempts by McNelly to charge him with cattle and horse thefts In September of 1876, McNelly learned of Fisher's involvement in some recent episodes of "stock relocation" near Uvalde. From his sickbed, he ordered Sergeant Armstrong to take twenty-five Rangers and deal with the thieves. (In today's parlance, "alleged thieves.")

From their camp at Oakville, Armstrong's men made the one-hundred-mile ride to Carizzo Springs at lightning speed. They were determined to catch not only King Fisher, but some bank robbers from Goliad who were reportedly hiding in the area. Armstrong's instructions were simple.

"Boys, we are going to capture those thieves or kill them. The reason I did not bring more men along was because I was afraid these fellows wouldn't resist if we were so many."

Arriving in the area, they almost immediately captured five suspected thieves, among them one Noley Key. Armstrong had him roped around the neck and suspended a few feet in the air while they questioned him. Key agreed to guide them to a camp on the west side of Espantosa Lake where a horse herd was being held pending their sale to another group of entrepreneurs camping on the Devils River. Key also informed them that King Fisher had left a few days earlier with a herd of cattle to be sold in far west Texas.

Armstrong elected to deal with the horse thieves at Espantosa Lake first.

"Key tells me that the gang stood off the sheriff and his posse a few nights ago, and so they will be looking for officers and be prepared to fight. That is just what we want. If they only fire at us, we can rush in on them and kill them all."

Under the light of a half-moon, a party of just five Rangers got within fifty yards of the camp when they were confronted by a sentry. The sentry fired at Armstrong

and missed his chance by mere inches. The night then erupted in gunfire in what was later referred to in the Ranger lore as the *Fight at Espantosa Lake*. By the time the Rangers made it to the campfire, all the horse thieves were either wounded or dead.

Ranger Jennings reported that as he approached the camp he had a shoot-out with one of the bandits named John McAlister. McAlister was blazing away with his pistol while cursing, something that only ended when Jennings shot-away McAlister's jaw with a rifle shot.

At the same time, Ranger Boyd fought it out with one John Martin, known in the Ranger "Crime Book" as One-Eyed John. He had a gouged-out left eye and was known to ride with another notorious bad man by the name of Burd Oberchain. Martin was a large man and had already taken a wound to his hip. After emptying his pistol at Boyd with no effect, he tossed the empty pistol at Boyd and drew a large knife from his boot. When Boyd's Winchester jammed, Martin hurled himself at Boyd. Boyd dodged Martin's knife and drew his own blade. By the tine the fight ended, both men had suffered multiple stab wounds. The knife fight ended when Boyd rode Martin's back into the lake. After several desperate minutes, Boyd emerged alone from the lake.

Sergeant Armstrong was able to identify four of the dead bandits listed in the Crime Book. Somehow, bandit Jim McAlister was discovered still alive. Armstrong ordered both Ranger Boyd and McAlister to be taken to the nearest doctor.

Another party of Rangers had been assigned to the far side of the lake to cut off any escapees from the attack on the main camp. Those Ranges rounded up seven prisoners. By the time the night was over, the Rangers had taken captive some twenty-two thieves. All of the prisoners were tied together in pairs before mounting bareback horses for the grueling thirty-five-mile ride to Eagle Pass.

Sergeant Armstrong's report on the action pleased Captain McNelly. In January of 1877, Captain McNelly was deemed unfit for service and summarily discharged from the Rangers. It was learned that the medical bills submitted by Dr. Cupples amounted to almost one-third of the total needed to pay the entire company.

McNelly had served Texas well but was now simply "kicked to the curb." McNelly had no choice but to return to the family farm at Burton. Defeated, defamed, and gravely ill, Leander McNelly died of tuberculosis on September 1, 1877. He was quietly buried in Washington County, where the cattle baron Richard King erected a tall gravestone to commemorate his service to Texas.

#### Match Starting Time And Range Rules

Access to the Cowboy Action Shooting Range will be available only after A Place To Shoot opens at 9:00 AM.

Please do not attempt to enter the range parking lot via the dirt bypass road.

Please enter the CAS range through the side gates by the pistol range or around the right side of the building, Matches start at 9:45 AM.

Registration will close by 9:30, With the shooter' Safety Meeting to follow.

Please, present no bills larger than \$20 at registration.

Guest shooters must read and sign a liability waiver before the match.

The gate to the CAS range should be closed during a Match. Be aware that visitors may come on to the CAS range who are not familiar with CAS safety protocols.

Members having concerns or complaints about range issues shall communicate those issues to the Pistolaros club officers.

#### South Texas Pistolaros Guest Shooter Policy

Visiting shooters unknown to club members but possessing a valid SASS Membership who wish to register as a competitor will be a assigned a Pistolaros Officer or member as a "shooting buddy" for at least one stage. New-to-CAS individuals or guest without a valid SASS membership but with a **documented** knowledge of safe firearms hand skills (LTC, NRA certification, etc.) who desire to participate in a club match will be referred to the Range Master, or other designated Officer, for on-site orientation. If time permits, the orientation will be held before the match. If the Range Master and Match Director concur, the individuals will be assigned a mentor and permitted to register as a competitor.

Any person who have not completed any type of formal firearms training but wish to participate in CAS will be referred to a formal CAS orientation session to be provided by the club. The orientation session will use a classroom setting to address basic firearms safety, handling CAS firearms safely, **SASS** match protocols, and range and club safety rules. Upon successful completion of the classroom session, attendees will have the opportunity to shoot in a controlled setting on the CAS range. Cost per students has yet to be determined, but a range fee of \$11.00 per person plus the cost of suitable ammunition is to be expected.

#### **Guest Shooter Liability Waiver Policy**

<u>Any</u> contestant at a match who is not currently a member of the South Texas Pistolaros must first read and sign a liability waiver before competing.


It's a lever-action, breech loader. Usual barrel length's 30 inches. This one has an extra four.


It's converted to use a special .45 caliber, 110-grain metal cartridge, with a 540-grain, paper-patched bullet.




